4. St. Mary’s College, Laitumkhrah, Shillong has the right to accept cancel the quotation if goods supplied by them are not according to the tender.
5. Tenderers are required to send the detail descriptions of Machines/Equipments.
6. The copy of documents regarding Govt, Registration, taxes, etc may be submitted along with the tender.
